## RULES AND REGULATIONS

### **DISCIPLINE**

- All the pupils must report in the prescribed school uniform.
- They are required to join the school on the notified day at the beginning of the term. Since discipline is given priority, a fine will be imposed on all the late comers unless the principal is informed well in advance and is satisfied about the reason.
- The school values discipline. Disobedience, slackness and disregard of rules are viewed as an obstacle to education and character building. Any misconduct or misbehavior, any breach of common sense or good manners will be treated with firmness. The school reserves the right to expel or suspend any pupil on ground of indiscipline.

### **LEAVES AND ATTENDANCE**

- Absence from school over a period of ten days without acknowledgement intimation can lead to the automatic expulsion or suspension of the pupil on disciplinary ground.
- The school shall remain indemnified against all claims arising due to illness or any other accident.
- Parents will surely appreciate that absence during the term will adversely affect their child's performance. In the interest unavoidable circumstances during the academic session will be granted by the Principal only. Application for such leave must be made in advance by the parent/guardian.
- In case of illness extending over a week a medical certificate from an MBBS doctor must be furnished before returning to school.
- Each student is required to have 80% attendance as a precondition for promotion.

## GENERAL FOR STUDENTS

- Once in two months, the school remains open for parents to come and see for themselves the working of the school. We encourage parents to visit the school on these days and to give their valuable observations and suggestions for the better management of the school.
- One calendar month's notice is required for the withdrawal of a day scholars. A boarder can be withdrawn from the school only at the end of the academic session. In the event of a child being withdrawn from the hostel, the fee paid shall not be refunded in any case.
- Boarders are not allowed to keep any costly items such as, gold ornaments and electric gadgetry with them.
- Any damage done to school property must be made good by the student concerned.
- If a student is caught using unfair means in any examination he/she will be sent out of the hall and 'O' will be awarded for that subject.
- The school is not responsible for goods lost.
- Students are advised to use sharpener and avoid use of blades.

## GENERAL FOR PARENTS

- ***Parents are required to keep the receipts issued to them as proof of Payment.***
- ***All accounts must be settled in full before the beginning of the examination/at the time of requisition of Transfer Certificate. If the fees are not cleared on time pupils will not be allowed to sit in the examination as well in the classroom.***
- ***Fee charged will not be refunded in any case whether days scholars or boarder.***
